



Chairperson's Report



A MESSAGE FROM THE CHAIRMAN – STEPHAN G KNOLL

As this governance year drew to a close, I wanted to reflect back on the year that was and to look forward to the exciting period ahead.

Our task as a Board continues to represent active member numbers, increase community engagement and seek increase in economic activity within the precinct.

We have remained focused on the positives and seek to influence wherever possible to shine a spotlight on what does and should make a difference in this truly great commercial precinct.

It certainly is the case that 2019 was our **“First Year of New Development”**. This includes the new Hub development which in the past year has created activity and impacted heavily on traffic flow, dramatically altered the skyline along the main street. Its presence and the intended streetscape improvements will influence further interest. The continued monitoring of foot traffic to determine increase in shopper and visitor numbers highlights that as a business community we need to keep abreast of a trend which indicates an increase in population diversity. This of course brings with it both challenges and benefits, on one hand attracting particular groups and alienating other demographic groups. Other influences on local city centre trading is the continued prevalence of development of smaller non-central shopping centres, which all chip away at the traditional business models of current businesses here in the centre.

Parking close to shops and businesses remains a problem and the introduction of 3h time zones in many carparks, causing angst for both customer and employees alike, and further resulting in the raising of many additional signs which indicates customer parking only. The board remains in constant dialog with Council to seek a positive pathway forward which allows customers to park close to the shops they purchase from while at the same time to seek safe and secure locations on the fringes of the centre with the introduction of fencing, lights, CCTV cameras and a possible employee shuttle to bring employees safely into and out of the centre.

No doubt 2020 is set to be an exciting year!

The Board is looking forward to seeing further positive change and developments that we will continue to attract further popular retail and service enterprises, both independent traders and franchise businesses. Hard work and strong financial governance over the past three years has given the SBA a sound financial base and created a steppingstone to support this change and new projects.


