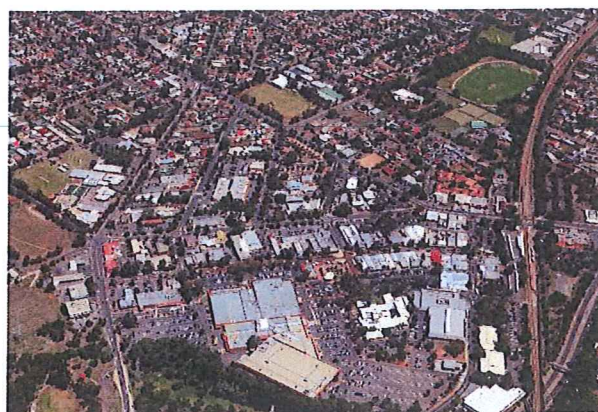

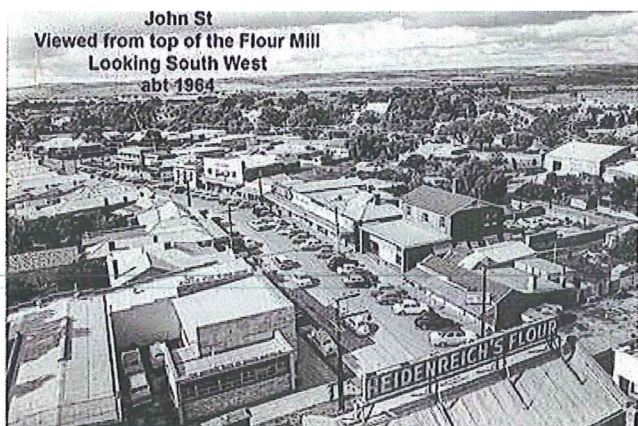

## Treasurer's Report



We can all agree that this past year has been a very different business environment to what we are all used to. Business wise, the pandemic has been damaging and unrelentingly cruel to many while at the same time some businesses have reported (or not reported so as to not “rub it in the faces” of those who have struggled) stories of success and prosperity.

Our hearts go out to pubs, restaurants, movie theatres and entertainment venues have been financially crippled with restrictions, while other businesses like traders in hardware, paint and building materials have prospered. Customers unable to travel interstate or overseas are turning their efforts to home renovation and home improvement plus in recent months increased travel within our own state has seen caravan & camper sales soar.

So, how are we, The Salisbury Business Association faring? Financially, we are fine, and you would expect, as our regular annual expenditure has decreased markedly being unable to hold our regular series of Events and Shows for the Salisbury City Centre. This inability has also resulted in our income from event sponsorship ceasing. Although our regular running costs have remained, we have still been given the opportunity to shore up our strengths in readiness for our coming public Events and Shows. Our EO, David Waylen, being the productive man that he is with his eye always on the challenge, has kept himself busy creating and implementing new initiatives to assist and benefit the Landowners and Traders of the Salisbury City Centre.

I am also pleased to report that in recognition of the pandemic and the reduced requirement for funding, the Members of the Board of the Salisbury Business Association, in a meeting earlier this year, passed a motion to request a 25% reduction in funding. This was accepted and enacted. We hoped that this reduction would help to ease the financial burden impacting on our members, the property owners and local businesses due to the pandemic.

Looking ahead, by all indications, it seems like we may be back to normal (or near normal) in the not too distant future. We are looking forward to again holding our regular community events like the Annual Christmas Parade, Food and Cultural Festival and Motorcycle Showcase. We have also some new ideas to further promote and enhance the popularity of the Salisbury City Centre.

Having been a property owner and trader in the Salisbury City Centre myself since 1989, I have seen some good change. Our Association intends on delivering further positive change.

I have now enjoyed my Fifth year on the Board as Treasurer, and I look forward to next year. Our EO, David Waylen has served about the same amount of time during which he has implemented many new Events and initiatives to promote the Salisbury City Centre. Our Association has benefitted greatly from having David “running the Show” and I am pleased to continue to offer my support to him and the Association.

With the first half of the 2019/20 seeing more engagement with our customer base through an expanded event and marketing program including our annual Business Awards, Food and Cultural Festival, Community Christmas Parade and Christmas Markets, the pinnacle event during the period was the opening of the Salisbury Community Hub.

What a great weekend this was. The much-anticipated addition to the City Centre, bringing the Council administrative functions, Council Chambers, Library and multipurpose spaces all under the one roof along with the redeveloped Salisbury Civic Plaza was well received by our business and

wider community alike.

Our new Hub will be the centerpiece for many activities/events over the coming months and years.

Highlights for 2020 included our partnership with Rik's Grill to host a fundraiser for our amazing Salisbury CFS, who had been working tirelessly across the summer both locally, on KI and interstate. This was a great community event to support a great community organisation.

Council approved the \$3 million budget for the John Street Improvement Project and is also progressing the Church Street upgrade and extension, which are both fantastic outcomes for our local businesses and the wider Salisbury community. This will herald a new era, changing the John Street landscape and ease of access to the City Centre. 2021 is going to be such an exciting year!

March to June was a very tough time for many of our businesses, and the Association responded with sharing and providing information, often on a daily or second daily basis, as well as providing whatever practical assistance and advice our local businesses required. Taking into account the ongoing difficulties being experienced by many businesses, the Board unanimously voted to reduce our Special Rate Levy request by 25%.

Throughout this time, our local businesses and property owners have looked to find additional ways to support each other as well as how to continually adapt to an ever-changing environment.

The resilience that you have shown, the commitment to maintaining services with less, the ability to adapt in uncertain times has been nothing short of amazing it is such a pleasure to be able to work alongside such dedicated, committed and passionate locals and it will be this spirit that will get you through the coming months as things return to a sense of normality.

I take this opportunity to remind you that the Association is here to help you any way we can, please reach out if you feel that we can be of any assistance or can provide you with any support and feel free to contact me anytime you want

- Encouraging and supporting the dynamic mix of traders/businesses across the Salisbury City Centre into the future;

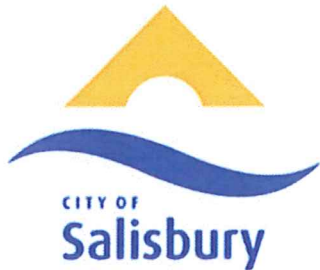
## Opportunities

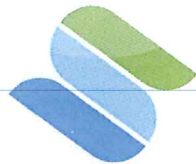

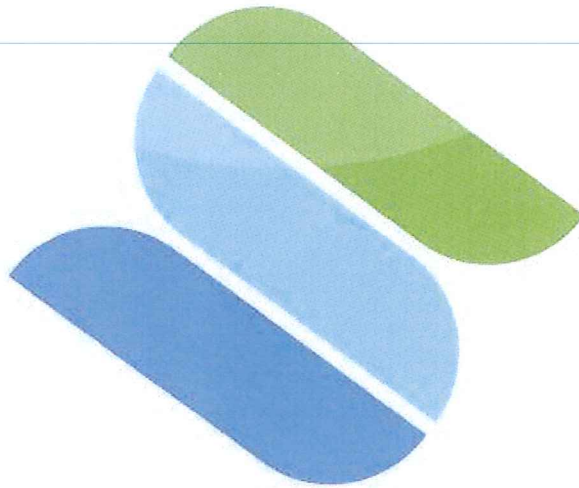
