4.4 **Concerns re. Council Meetings**

Over the past few months, there have been mounting issues around ratepayer representation, and personal Councillor driven agendas from two of our elected members, one who represents members of the Salisbury Business Association.

These issues have led to disharmony within the chamber, verbal and social media attacks on Council staff and members of the public including our Executive Officer.

With the crucial budget deliberation period upon them, the Board endorsed our Chair, Marty Edwards to write to Council expressing our concerns and wishing the focus to return to effective collaboration and delivering good governance and outcomes for the City of Salisbury.

Shopfront Improvement Grant Program 4.5

One business has applied and was endorsed for funding approval.

5 other businesses expressed interest, but with the timeframe to apply over Christmas, difficulties engaging with contractors affecting their applications.

Council to be encouraged to open a second round this financial year.

John Street and Church Street Renewal Update 4.6

The Church and John Street Revitalisation Project continues on schedule with the bulk of the civil works now complete. Balance of works hoped to be completed by early mid April.

- The public toilet has been installed
- New LED Street Lighting and improved CCTV cameras being installed
- Judd and Sexton Laneway upgrades commenced (Sexton Laneway is 85% complete and has re-opened to the public)

4.7 Business Watch Safety and Security Update

Very positive feedback from the community for the SA Police information stand at the Salisbury Fringe Carnival this year. Great engagement opportunity. Thank you to SA Police.

David raised concerns re. the significant increase in graffiti attacks across the SCC, and has shared these concerns with SA Police via Jackie. The Business Watch Report also raised concerns around the current spate of assaults and the high volume of retail theft related reports, especially alcohol).

SA Police continues to work with alcohol retailers to try and curb these instances.

4.8 Executive Officer WHS Protections

4.8.1 Safety and Security Audit SBA office

Sgt. Jackie McDonald's Audit was circulated to Board Members via email and Joe Balawejder on the day, at the meeting. Special thanks to Jackie for the extensive report supplied to the Association.

Areas identified from the Audit addressed to date:

- Off-site storage space contracted with National Storage Salisbury Plain
- Test and Tag arranged for all electrical items
- Landlord contacted re. the need for smoke detectors
- Investigate duress alarms

4.9 Potential relocation of the SBA Office

In light of the concerns and issues raised, the Board discussed the Office Safety and Security Audit, agreed that the current office arrangement was not suitable for it's employee/s, was not 'fit for purpose' and adopted the discussion position to relocate.
