AWFOSA Award for Excellence



Recently the African Women's Federation of SA (AWFOSA) won the Women's and Children's Hospital Create Award for Excellence in Consumer Partnership for the work they have

done in the Maternal Health Care Project.


This Project has been collaborating with the Women's and Children's Hospital for over 2 years, to share and embed African women's voices into the hospitals as they are cared for in pregnancy and birth, creating safer and more culturally appropriate care for the diverse range of African women in SA.

The Award acknowledged the Maternal Health Care Project for joining with the WCHN in codesigning 2 Forums where African Women, Midwives, Researchers and Staff came together to discuss the major problems they identified in Focus Groups. There are now significant changes being outworked in the WCHN including awareness and provision for culturally appropriate food during and after birth, as well as a Pregnancy Cultural Care plan being developed.

The AWFOSA is also involved with the New Women's and Children's Hospital Project, ensuring that the African women's voice is embedded into the new Women's and Children's Hospital being built in the coming years. This is a wonderful contribution and spearheads CALD involvement for the future.

They are also looking forward to the next 2 years extending the work into the Northern suburbs where there is a great need. The MHCP is proudly funded by the Department of Premier and Cabinet and the Stronger Together Grant and has been extended for a further 2 years.

KNOWING THE FIRE DANGER RATING MAY SAVE YOUR LIFE

Fire Danger Ratings are now simpler and easier to understand. By using the latest science and technology, they provide a more clear and accurate rating to save properties and lives. The Fire Danger Ratings give you an indication of the consequences of a fire, if a fire was to start. The higher the rating is, the more dangerous the conditions will be.

Mandatory Food Safety Training For staff and volunteers

A new national Food Safety Standard has been added; Standard 3.2.2A: Food Safety Management Tools. Businesses must have the new requirements in place by <u>8 December 23</u>.

The Standard introduces new requirements for businesses that handle unpackaged, ready-to-eat (RTE), and potentially hazardous foods.

Businesses must implement the following new food safety management tools:

- mandatory food handler training
- implementation of a food safety supervisor

To do this your business must:

- make sure all food handlers have completed a food safety training course or can demonstrate their food handling skills and knowledge.
- appoint a certified food safety supervisor and ensure they are reasonably available when the business handles unpackaged, potentially hazardous, RTE foods.

Out and about with Hon. Zoe Bettison MP ...

Christmas Day and Easter Sunday now declared public holidays

The government is fulfilling its election promise to make Christmas Day and Easter Sunday official public holidays.

These changes will ensure that employees who work on these special days receive fair compensation and also align SA with the rest of the country in terms of public holidays.

Currently, when Christmas Day falls on a Saturday, the public holiday is moved to the following Monday. However, under the new legislation, Christmas Day will be designated as a public holiday every year, regardless of whether it falls on a Saturday or Sunday.

The legislation will also bring South Australia in line with other mainland states by declaring Easter Sunday as a public holiday. Currently, most stores are not permitted to open on Easter Sunday, despite it not being recognised as a public holiday. These legislative changes are not only about increasing the number of holidays but also modernising and simplifying public holiday laws. The aim is to reduce confusion and improve consistency with other states, leading to fewer disruptions to businesses and enhanced tourism opportunities.

While this legislation addresses the declaration of public holidays, it does not regulate shop trading hours or the penalty rates workers are entitled to receive for working on public holidays. These aspects are dealt with under separate legislation & not part of these reforms.

SCC Business Watch ... Online Shopping: Don't get scammed this Christmas!



Follow this simple secure online shopping checklist

 Shop using secure devices. Make sure the devices you use for online shopping have the latest updates installed

and are connected to a trusted network. For example, use your home Wi-Fi or cellular (4G/5G) connection rather than public Wi-Fi.

2. Protect your payment information and accounts. Be careful saving payment information on an online shopping account. If you do save payment information to an account, you should turn on multi factor authentication (MFA) to protect it. If not possible, set a long, complex and unique passphrase as the account's password to

help keep cybercriminals out. You could also use a password manager.

- 3. Use trusted sellers. Research online shopping websites before you buy and stick to well-known, trusted businesses.
- 4. Know the warning signs. Extremely low prices, payments through direct bank deposits, and online stores that are very new or have limited information about delivery, return and privacy policies can all be signs of a scam.
- 5. Use secure payment methods. Never pay by direct bank deposits, money transfers or digital currencies such as Bitcoin as it is rare to recover money sent this way. You should pay by PayPal or with your credit card. You may want to set up a second card with a low credit limit and keep it specifically for online shopping. This will help minimise financial losses if your card details are compromised after shopping online.
- 6. Don't engage and report suspicious contact. Be aware of any strange phone calls, messages or emails you get about online orders. It could be someone trying to get you to share your personal or financial details. If someone contacts you about an order you don't remember placing, it could be a scam. Stop contact and reach out to the store using the details on their official website to check.
- 7. Watch out for fake delivery scams. Don't let your guard down while you're waiting for your goods to arrive. Cybercriminals can send fake parcel delivery notifications with links that could trick you into downloading malware or giving away your personal details. If you receive such a message, do not click on the link. Delete the message immediately. You can contact the seller or the courier company using the details on their official website. Scamwatch has examples of what these fraudulent text messages may look like.
- 8. Take additional precautions It is always a good idea to limit the amount of personal information that you use on websites. Ask yourself if the website really needs this

extra information or an account to complete the transaction.
